

Ancient Stone Structures and the Nephilim / GIANTS

To read detailed historical evidence from various cultures from all around the world, refer to the book **“Science, Origins, and Ancient Civilizations”** beginning around page 119 to the end of that chapter (see TargetTruthMinistries.com).

Government public education in America since the 1960’s has removed the Bible and the concept of “Creation” from the educational curriculum. What is taught is the “theory of evolution.” **However**, even in 2025, this remains only a “theory,” with no actual hard evidence. **Why has historical evidence from various cultures around the world, which supports creation, and a flood, been removed from our public education system in America**, while “theories” of evolution persist ?

If God was *grieved* (regretted), that He had to destroy all this life, then *why did He have to do it?* What was the evil which caused God to destroy all life on earth with the flood—all except Noah and his family that is. Satan had corrupted the human population. God (in order to save us...in order to provide actual humans for Jesus to be born from), had to destroy it all (**Gen. 6:5**). Some people believe that there were millions of regular human people who were drowned in that flood. And, because of this belief that God destroyed regular humans that He made (including babies and old people), many believe that the God of the Old Testament was a vicious blood-thirsty being—not a loving God, and that abortion (killing babies), must be o.k. too. And, for this reason, many people have rejected God. The Bible tells us that God was *grieved* that He had to do this (**Gen. 6:6-7**—“repented” or “sorry” actually means “regretted”).

God had to destroy the “*mankind*” (**Gen. 6:7**), because the human population had actually become a “*hybrid mankind*”—genetically altered (corrupted--**Gen.6:4-5, 11-12**). Only Noah was “*perfect*” in his generations (**bloodline**—**Gen. 6:9**). Noah’s bloodline was perfect, not corrupted by Satan (**Gen. 6:9**—the King James says “perfect in his generations” and the NAS says blameless in his time—the Hebrew is “*without blemish in his bloodline*”). Satan had an evil plan to destroy God’s plan. God’s plan was to save people with the birth of Jesus through humans He had created for this purpose - not through some genetically altered (corrupted) beings which Satan had managed to produce. This deception (that God kills people arbitrarily), is right out of Satan’s play book. Satan has deceived us into thinking that God had people (people like the human generations we see today—the generations from Noah), destroyed in the flood. The human populations before the flood had been genetically altered (corrupted - **Gen. 6:11-12**)—no longer actually human – Nephilim / Giants.

Kids, and even adults today, think that after death, that people’s spirits are out there, and can be seen, and heard, and they look down on us, and that we can talk to them. Satan likes this, because as long as everyone thinks that after they die, they will be floating around somewhere (possibly able to come back to this world - even visit relatives on occasions), then people don’t see the need to really consider death, or hell as a final end. After all, if our spirit is floating around here, what difference does it make if I’m a Christian, or Satanist, or non-believer? Supposedly we’re all here together. Many people, today, actually believe this--that their loved ones are around here somewhere, and can be reached, and that they will somehow be all right--that God will somehow take care of things one day, including us, when we die. The truth is that God will not someday take care of everything, because He already has - 2,000 years ago. Jesus died for us 2,000 years ago, and He said *trust* in Him, and live. Deny Him, and spend eternity separated--isolated, alone, forever. God tells us in **Ecclesiastes 9:5-6**, and **1 Thessalonians 4:13-16**, that the dead have no further connection with this earth age we are in. They are in heaven with God, or in hell--all awaiting the final judgment at the resurrection. God describes the dead as asleep, at rest, at peace, awaiting the resurrection to their new supernatural bodies (**Psalms 139:8; John 11:11-14; Acts 7:60, 13:36; 1 Corin. 7:39, 11:27-32, 15:6, 15:17-18, 15:20, 15:51; 1 Thess. 4:13-15; 2 Peter 3:4**). The dead are not floating around with us here (**Job 7:7-10**). Those who have passed on from this earth who are “born again” (**John 3:1-7**), are asleep, at rest, at peace, and will awaken to their new resurrected body when Christ returns.

Jesus said that He was the only way to eternal life in heaven (**John 14:6; Acts 4:12**). Other faiths claim there are ways other than Jesus to heaven. Both of these cannot be true. Someone is lying. So, how did all these various gods and religions get started. Is the Bible correct that fallen angels have misled us (**Gen. 6:1-5**), and that ways other than Jesus are a perversion of God's plan by Satan (**Gal. 1:8-9**) ?

The Bible records in **Genesis 4:20-22**, that from the beginning man had knowledge—it was passed on from God through Adam and Eve to their generations. Remember that Adam was a “*son of God*”—different from you and I who are called “sons of men” (**Luke 3:38**). *All ancient civilizations* tell of receiving great knowledge from beings from heaven (**Gen. 6:1-5**). See the book **Eden to Evil @ Target Truth Ministries.com**.

In ancient Samaria (the oldest civilization—called “*The Fertile Crescent*”), great knowledge sprang from nowhere, including written language, astronomy, agriculture, chemistry, and mathematics. In the Sumerian myth, the god of water and wisdom (**Gen. 1:1-5; Prov. 8**), created man out of clay (**Gen. 2:7-8**), and the most powerful of gods called Anu was then superseded by a god called Enlil, the god of the heavens (*Satan*, **Eph. 2:2; 2 Corin. 4:4**).

Plato, in 360 B.C. wrote of the ancient great city of Atlantis from before the flood of Noah. The Greek texts record that a being from heaven called Poseidon took a woman as his wife, had children by her and founded Atlantis (**Gen. 6:1-5**).

Ancient Japan records beings from heaven called Dogu, who brought with them great knowledge, language, and building techniques.

The Hopi Indians from Arizona use Kachina dolls to tell their history of beings arriving from heaven.

The American Hualapai Indians left ancient petroglyphs in the area of Davis Dam, in California, near the Colorado River, depicting a vessel carrying eight people (including the chief), through a flood. William Hoesch, M.S. Geology, states that the Hualapai tradition closely resembles the story of Noah.

The Sahara Desert holds ancient cave paintings of beings coming from heaven.

In India, the Hindu claim ancient prehistoric beings came to establish their land. Krishna (a primary god of India), supposedly came from heaven and founded the city of Dwaraka. Sangam legends in India also tell of beings from heaven with great knowledge and power. Shiva, the primary god of death, is said to have come from heaven. Shiva is always pictured with a serpent.

In Central and South America, there are numerous indications of ancient beings with great knowledge and power. In Peru, around Lake Titicaca, the Aymana Indians tell of ancient beings from heaven who established the city of Tiahuanaco, and formed their civilization. An ancient site in Peru called Cavel (which includes a great pyramid), is the location of one of the oldest sites in the world (older than the Great Pyramids of Egypt), dating to 2600 B.C. (around the time of Noah's flood). The Mayan people at Tiahuanaco, located at 12,000 feet, in ancient times could produce seven times the average yield of crops today, even compared to modern techniques that we have today. There are three main pyramids at Teotihuacan in the Mayan area (similar to the three Great Pyramids in Egypt), which are part of an overall scale model of the Solar System, including the outer planets (which were not identified until the eighteenth and nineteenth centuries by modern techniques, per Hugh Harleston, engineer. The ancient Nazca Indians must have had the use of optics, because they could write so small that today a microscope is needed to read their inscriptions.

Stonehenge, in England, has concentric circles which relate accurately to the path of the planets circling the sun. We know that in our own history, people thought that the earth (not the sun) was at the center of the solar system (remember the argument between Galileo and the Catholic Church? The church held to tradition based on previous scientists who believed the earth was at the center. The Bible never stated that the earth was at the center, but people began to distrust the Bible as a result of the Catholic Church disagreeing with Galileo). Like the Bible, the builders of Stonehenge knew the truth about our solar system. Further, these stones are also

aligned to define the positions of the sun and moon during the equinoxes. Where did this knowledge of astronomy, and power to move these giant massive stones, come from?

The Greek legends record that Zeus (the sun god), and Apollo (the son of Zeus), were beings from the heavens with great power and knowledge. The story is that out of Zeus came Hera (like Eve from Adam—**Gen. 2:22**). Hera's name was changed to Athena after a great flood (**Gen. 6:17**), and she supposedly received her great powers and authority from the serpent—the source of knowledge in the Greek understanding (**Gen. 3:4-6**). Athena is always pictured with the serpent.

In ancient Egypt, the Book of the Dead records that the Egyptian people fled from the “Land of the Watchers,” called the Anunnaki in Sumaria. These “Watchers” supposedly came from heaven and were originally known as the Nibiru. The Nibiru ruled and judged man. The Bible records these names as the Anakim and the Nephelim, and they are references to beings from heaven, as well as their children born to human women (**Gen. 6:1-12**). The Dead Sea Scrolls reveal that about 200 of these fallen angels (Watchers), came to earth (**Jude 6**), 42 of which served Osiris, according to the Egyptian Book of the Dead. The fear of these Watchers caused the ancient Egyptians to elevate a goddess named Isis as a being to trust (the sister/wife of Osiris—she supposedly could protect humans because of her power granted from the serpent to overpower these Watchers, or fallen angels). Magic pagan practices from Isis came out of this fear of these fallen angels (Watchers).

In their book “*Discovery of Genesis*,” C.H. Kang, and Dr. Ethel R. Nelson report on **prehistoric Chinese idiographic pictures** used in ancient Chinese writings depicting the creation of man in a lush garden followed by the temptation and fall, and then a great flood with eight people surviving, and a tower, similar to the Tower of Babel—all biblically aligned. The Chinese history also records that the water for the flood came from “below” (as well as above), just as recorded in the Bible (**Gen. 7:11, 8:2**). An ancient Chinese writing titled “Feng-su T’ung-yi, states that all people on earth are descended from “Nu-wa,” considered an ancient version of the name “Noah.” The Chinese calendar begins around 2680 B.C., about the time of Noah’s flood.

In the Bible, Paul writes of the third heaven—another dimension (**2 Corin. 12:2**).

Jesus told us that His kingdom was not of this world—it was of another dimension (**John 18:36**).

Genesis 6 records that angels from heaven took women and had strange children from them—Nephilim, giants of great power and knowledge. This was Satan’s plan to destroy the bloodline of humans, so that the Savior (Jesus), could not be born (**Gen 3:14-15**). God saved Noah, who had a pure bloodline (**Gen. 6:8-9**), and God destroyed the evil up to that time with the flood (see Study on *Giants* @ TargetTruthMinistries.com). Noah's bloodline was perfect, not corrupted by Satan (**Gen. 6:9**—the King James says “perfect in his generations” and the NAS says blameless in his time—the Hebrew is “*without blemish in his bloodline*”).

Why is all this evidence of earth age and history absent from our government public education system?

From the Bible itself, to all the pagan myths recorded around the world—all this recorded information tells us that what is recorded in the Bible, about fallen angels and evil causing God to bring a flood, is supported by historical evidence. The Bible is true, and so is the reality of Satan’s influence in our lives (**Eph. 2:2; 2 Corin. 4:4**). Yet, millions of people, who are aware of the Bible, willingly choose to wander the planet and not study God’s Word. These people are *willingly ignorant* (**2 Pet. 3:1-7**).

Today’s public government education system denies all this world history while it promotes the “theory” of evolution over millions of years.

However, science and world history are pointing in the same direction that Moses wrote about thousands of years ago in **Genesis 6**. These “mighty men” were worshiped as gods by the people, and the true God had to destroy these early civilizations, including even the babies, with the flood because these “mighty men” had corrupted the human DNA pool (**Gen. 6:1-4, 11-12**). The knowledge and power of these “mighty men” was

eventually lost to future generations of humans. Even today, we are still mystified by these past civilizations of “intelligence” (see book “**Science, Origins, & Ancient Civilizations** @ **Target Truth Ministries.com**).

In **Job 8:9**, and **Ecclesiastes 9:11**, we are told there was more knowledge in the past, and that there is nothing new now.

We are told in the Bible that our battle is not really against flesh and blood, but against forces outside our dimension—spirit forces (**Eph. 6:12**). We live in a “natural” environment, and find it difficult to imagine things like fallen angels (pagan gods), and also Jesus rising from the dead, and our own future resurrection from the dead to eternal life—somewhere. But, Jesus gave us the evidence. He remained on earth for many weeks, visiting with hundreds of people, to give us the eyewitness evidence that life after death is real—and that evil is real...so...I hope we don’t blow it (**Acts 1:1-8; 1 Corin. 15:1-8**).

Why do government education programs forbid all this information to be taught?

Jesus said that He was the only way to eternal life in heaven (**John 14:6; Acts 4:12**). Other faiths claim there are ways other than Jesus to heaven. Both of these cannot be true. Someone is lying. So, how did all these various gods and religions get started? Is the Bible correct that fallen angels have misled us (**Gen. 6:1-5**), and that ways other than Jesus are a perversion of God’s plan by Satan?

Ironically, science, itself, is questioning today how post-stone age humans were able to construct the Egyptian pyramids, Sphinx, Ankor Wat, and Tiwanaku with their alignments to constellations dating back to 10,500 B.C.

When the world was supposedly just emerging from the stone age, it’s interesting to note that the great pyramid of Egypt had each of its sides constructed with a curvature inward to signify the exact curvature of the earth. This is significant, because at this early date most everyone supposedly thought that the earth was flat.

Rene Noorbergen in “*Secrets of Lost Races-New Discoveries of Advanced Technology in Ancient Civilizations*,” states that in Peru, in Sacsahuaman, huge stone blocks weighing up to 20,000 pounds were used in the construction. This feat was not equaled in our modern world until the 20th century.

Also, science is questioning how other cultures, like the Maya, whose knowledge of math and astronomy was seemingly far beyond human ability, without a higher power, or some outside higher intelligence, how they were able to develop their calendar and enormous stone buildings and pyramids, which have stones just as large as the pyramids of Egypt. Mayan, Aztec, and Egyptian histories all refer to “giants.”

It is interesting that up until the year 1517, when the Turks removed the white casing stones from the Great Pyramid to build their empire, that the Great Pyramid in Egypt had a covering of polished white limestone blocks, each averaging thirty-five square feet in size. It is estimated these stones numbered 144,000. This is ironically the same number of Jews from the twelve tribes, to which **Revelation 14:1** makes reference. Another striking imitation of Christ’s kingdom.

One will recall that in Genesis, God tells us of the “giants” and “mighty men,” and warns us repeatedly not to worship these “sons of God,” “the fallen ones,” these “men of renown” (see other books in this series, **Eden to Evil**, and **God’s Plan / Satan’s Plan** @ **Target Truth Ministries.com**).

Why do government education programs hide all this history?

Ancient Egyptian texts refer to the “First Time” (Zep Tepi), the time of creation, as the era of the Neferu (Netheru - translated as human beings with god-like abilities). According to J.J. Champollion- Figeac in *Wisdom Literature*, Paris, 1888, the Egyptian Book of the Dead states that one of the “Company of the gods, Thoth”, built the Great Pyramid according to a design which had descended from heaven. Ancient Sumerian texts speak of highly developed people who descended to the earth from the heavens, who developed into a people called the Nephilim (see also Bible references – Genesis 6). The Akkadians called them the Ilu, or the “High Ones,” per Zecharia Sitchim, Sumerian language specialist.

Greek historian Herodotus wrote 2,400 years ago of the Great Pyramid's white casing stones being finely fitted together, polished, and engraved with signs and symbols. Jewish historian Josephus 2,000 years ago also wrote of these, and noted the engravings recorded "a peculiar sort of wisdom."

Eighth century Arab astronomer Abou Balkhi recorded in a scroll held at the Oxford University library, that the Great Pyramid was inscribed with the wonders of physics. These disappeared when the white casing stones were removed in the 1500's.

The British museum holds a tenth century manuscript No. 9576, which records Arab historian Masoudi's testimony of the Great Pyramid as having carvings on the white casing stones of celestial spheres and stars, their history, and progression. These white casing stones were removed by the Turks in the 1500's.

The Alexandrian library holds an eighth century book about Egypt's past called Camoos (Dictionary) of Firazabadi, which records that the Great Pyramid was built **before** the time of a great flood in ancient times.

Herodotus records in his *Histories* that the Great Pyramid showed evidence of **salt water calcification, and sea shells** all around the area. This testimony was supported by Danish author Frederic Norden in the 1750's, who noted the great number of shells and oysters covering the plains around the pyramids (it should be noted that the Nile River has no shellfish, or salt water).

The Alexandrian library holds a document written by Arab historian Ibn Abd Hokm that claims that some pyramids were built by a king named Saurid Ibn Salhouk more than **300 years before a great flood occurred**, and that the Great Pyramid was already in existence at the time of the flood.

Robert Bauval in "*Secret Chamber: The Quest for the Hall of Records*" notes that beneath the Sphinx, holes drilled struck red granite instead of the natural limestone. Red granite is not native to the Giza plateau. Further, it is noted that drainage tubes extract water equal to three Olympic pools each day from beneath the Sphinx, indicating a giant chamber is located under the Sphinx. Egyptian authorities will not allow excavations of this area, fearing that a discovery of some intelligent source (not Egyptian), would take away from their heritage of being the people who built these structures.

There are numerous ancient stone structures all around the world which show evidence of great knowledge and super-human strength to move these large stones, and that they also probably pre-date the flood of Noah. The **Pyramids of Egypt** with 15 ton stones are obvious and easily identified. Others are as follows :

Tiwanaku Bolivia at 12,000 feet is constructed with huge interlocking stone blocks weighing 85 to 130 tons each. Modern historians point to evidence that about 10,000 people lived there in the recent past, and they did this with no written language.

Caral in Peru is said to be the oldest human site in America dating to 2,600 BC with several stone pyramids supposedly built by a population of about 3,000 according to modern historians.

Stonehenge in England is constructed with 25 ton stones, and aligned to the solstices, and dated to 3,000 BC. by modern historians.

Sacsayhuaman in Peru – Cuzco, at 12,000 feet, has stone structures with 20,000 pound stones that measure 12 feet by 20 feet and interlock with such precision that no mortar is needed.

Gobekli Tepe in Turkey dated to 7,000 BC, has 200 massive stone T-shaped pillars weighing up to 50 tons each.

Ollantay Tambo in Peru (Urin Pacha), at 9,000 feet has huge interlocking stones in a Temple complex.

Karnak in Egypt has obelisks – 122 that are 33 feet tall weighing 300 tons each, and 12 that are 69 feet tall and 10 feet in diameter, along with stones on top of these columns weighing 70 tons each.

Tannis in Egypt has huge stone obelisks up to 20 tons, and walls which have engravings that show signs of

machine precision, and all this predates more recent occupations.

Malta Temple of Italy is a great stone structure dated to 5,000 BC aligned to solstices and equinoxes.

Heliopolis in Egypt is a great stone structure with 120 ton stones.

Baalbek in Lebanon is dated to 7,000 BC, and has massive stone blocks weighing up to 600 tons each.

Machu Picchu in Peru is a huge stone city attributed by modern historians to the Inca people who lived there for about 100 years, with a population of about 1,000, and no written language.

Easter Island Moai Stone statues weighing up to 82 tons were somehow carved, moved, and erected.

Sanxingdui China the Terracotta Army is attributed by modern historians to the first Emperor, but is a 22 acre pyramid site with hundreds of statues and bronze masks that no actual evidence can link to the first Emperor.

Pohnpei Island in Micronesia – Nan Midol - has a stone temple pyramid with thousands of huge stone interlocking pillars 10 to 60 tons each up to 20 feet in length covering many acres.

In all these cases, the peoples who inhabited these structures in recent history are the people who modern science attributes their construction to. However, there is no actual evidence to support their ability to move these stones or construct these vast structures. Biblically, giants / Nephilim possessed both strength and knowledge to build these structures, and God destroyed these ancient beings in a great flood, which many ancient cultures agree with. **But, our government public schools ignore all this history.**

The pagan gods of history (Nimrod, Anu, Ra, Osiris, Zeus, Apollo, Thor, etc.), are all perversions of the plan of God to save us humans who have fallen (Adam and Eve being the example). This plan was originally recorded for us in the heavens—in the stars—in the Zodiac (**see Zodiac Study @ Target Truth Ministries.com**), where God named all the stars (**Psalm 147:4; Isa. 40:26**), and laid out the story in twelve segments (twelve constellations), so that all mankind anywhere in the world would understand God’s plan (**Job 38:32; Gen. 1:14**). God’s plan is that because we have fallen, and need a Savior, that He will destroy Satan, and that Jesus will eventually bring in a new world. Satan has perverted the Zodiac’s story, so that today we have lost its original meaning. But, the names of the stars have survived and still tell the story of salvation, the virgin birth, the sacrifice of Jesus, and the reconciliation of those who trust in Jesus to heaven—as well as those who deny Jesus to hell.

All these ancient “gods” (**giants**), either came from heaven (**Gen. 6:2**), or were born to them (**Gen. 6:4-5**). Satan, through these fallen angels (**Jude 6**), provided mankind with **giant beings of power and knowledge** to worship, follow, and fear. Today, most people discount ancient pagan gods (even though the Bible indicates these fallen angels—beings of great power and knowledge—*did exist*—they were evil fallen beings). Regardless of whether you believe the Bible or not, many of the practices of these evil beings still exist—fortune telling, abortion, tattoos and piercings, sacred words and chants, drug use to promote altered states, worship of the earth and nature, and belief in zombies, werewolves, vampires, and ghosts. Even the acceptance of open adultery, homosexuality, transgenderism, and transsexualism are directly connected to the son of Zeus—Dionysus—the god of lust and ecstasy. These perversions of sexuality were promoted by Dionysus by threatening anyone who opposed them with some form of mental illness, either to afflict them personally, or to afflict their children. Thus, these lusts (which are natural to man’s flesh nature anyway), were given legitimate status by the world, because the object was to protect your family from Dionysus by being promiscuous (which is natural to man anyway—if it feels good, do it). This same acceptance of perversions of sexuality is also being embraced today. It is natural for us all to lust, and today instead of some false god telling us to “*just do it*,” mankind themselves have elevated these perversions, even having “pride” in perversions, and declaring any opposition to them as discriminating. God, of course, *does* discriminate, but we have now set ourselves above God. Satan always takes our natural sin nature (we all have it—**Rom. 3:10-12, 23**), and finds a politically correct popular way to grant us “permission” to follow this sin nature, and to deny Jesus. When we follow these worldly ways, we are following Satan, and not God (**1 John 1:5-10, 1 John 2:15-17**).

We are told in the Bible that our battle is not really against flesh and blood, but against forces outside our dimension—spirit forces (**Eph. 6:12**). We live in a “natural” environment, and find it difficult to imagine things like fallen angels (pagan gods - aliens), Jesus rising from the dead, and our own future resurrection from the dead to eternal life—somewhere. But, **Jesus gave us the evidence**—He remained on earth for many weeks after His death, visiting with hundreds of people, to give us the eyewitness evidence that life after death is real—so, please don’t blow it (**Acts 1:1-8; 1 Corin. 15:1-8**).

What positions do our government public schools take concerning Biblical truths ? They ban them !

Darwin, in his own writings, questioned whether his “theory” would hold up. Darwin stated that the theory of evolution requires that innumerable transitional fossils must be found to prove evolution theory is correct. Transitional fossils must be found to prove evolution. We still don’t have the fossil evidence to support evolution. The theory still exists, but the evidence does not.

In fact, today science knows that many of the theorized transitional forms were actually contemporaries (existing at the same time). Homo sapiens (us), Neanderthal (archaic Homo sapiens), Homo erectus, and Homo habilis, were all contemporaries, existing at the same time, and thought by science today to have even interbred. In other words, the fossils look a little different, but they appear no different than Eskimos and Europeans look today.

In the book, **“Science, Origins, & Ancient Civilizations”** on pages 67-91, fossils and DNA evidence for macro-evolution are discussed in great detail.

In an article titled “No Bones About It”, **Dr. Cupps, PhD. in Nuclear Physics**, writes that the scientific observable evidence for macro-evolution has yet to be produced. He states that in fact, just the opposite is true—evidence is pointing to a human family with different ethnic groups, with no evolution suggested. The book, **“Science, Origins, & Ancient Civilizations”** covers these issues concerning many human types (species) actually living at the same time (pages 80 ff).

However, other scientists, referred to in *Science News*, in April 2004, continue to believe that life itself (much less macro-evolution from life), can accidentally happen. **Chemist Terry Lee, and John Sutherland of the MRC Lab of Molecular Biology in England** report they believe that compounds for life all emerged accidentally together in a singular event triggered by natural forces of water, energy, and chemicals. The book, **“Science, Origins, & Ancient Civilizations”** details what is needed for life:

“The problem for life originating naturally is that science has discovered that DNA, proteins, RNA, and the cell are all required to develop simultaneously. None can exist without the other. Fred Hoyle, British Astronomer, and Francis Crick of the Salk Institute of Double Helix fame, have each suggested that life could not have begun without some unknown outside influence (space aliens).

DNA, which stores genetic information (the blueprints of life molecules), cannot function without proteins, and RNA molecules.

RNA (which transports the correct blueprints to the proper location site for life molecules), cannot function without proteins, DNA molecules, and a cell.

Proteins cannot function without DNA and RNA molecules.

A cell cannot survive without RNA molecules.

Dr. Francis Crick, Nobel Prize medalist in DNA, says there is no mathematical possibility of DNA occurring naturally. DNA is a binary 4-bit code, multiplied thousands of times. Life is intelligent software, not simply chemicals and elements. It takes millions of these 4-bit codes to make even a simple cell, much less a complex organism. There is actually more data encoded in the DNA of a single cell than there is data required to construct the space shuttle.”
